The Northgate Board of School Directors, at last night's Reorganization meeting elected Mr. Gary Paladin as President, and Mrs. Brigitte Jackson as Vice President, and Mr. Daniel O'Keefe as Treasurer. Also, the Board appointed the law firm of Andrews and Price, as represented by Patricia Andrews, to serve as the School District Solicitor.
